

Ohio Partners for Cancer Control (OPCC) July 2020 Meeting Evaluation Results

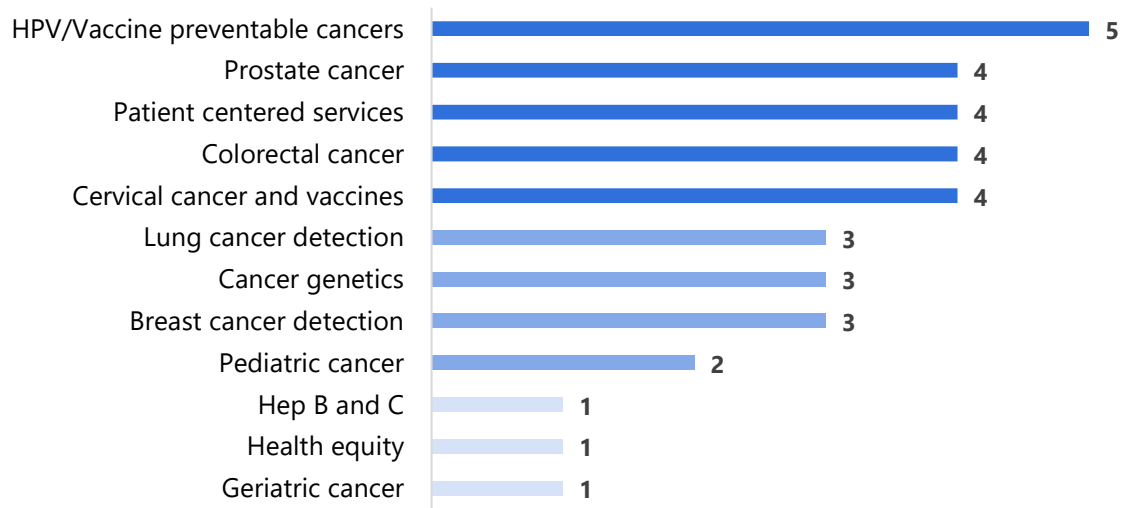
28 Total Surveys Completed (29 surveys started)

35% survey response rate (28 out of 79 meeting participants)

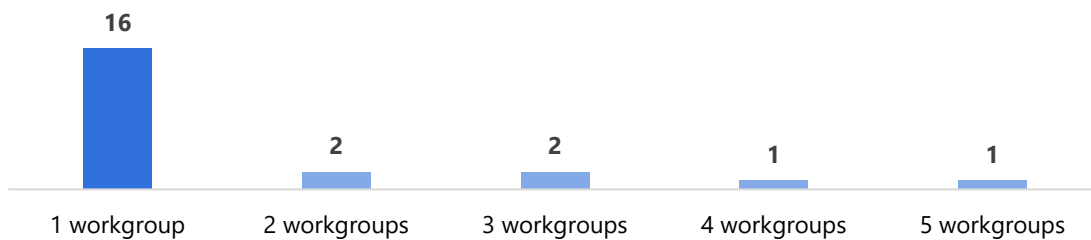
Description of Survey Respondents

- **96%** (n=27) are a current OPCC member. One respondent reported "I am not sure."
- **82%** (n=23) participated in a Topical Workgroup to develop Cancer Plan goals

NOTE: The five participants that reported “**Yes**” to having questions or concerns about the new Cancer Plan process were members of the Topical Workgroups for *Patient centered services* (n=1), *Genetics* (n=1), *Prostate cancer* (n=2), and *Cervical cancer and Colorectal cancer and pediatric cancer* (n=1).

Please describe any questions or concerns you have about the process for developing the Ohio 2021-2030 Cancer Plan...

- We are still not identifying how we can [directly help metastatic patients](#). We need to see them and identify this population in all of our work. This should not just be a document for early stage patients. As those with metastatic disease are at times living longer, we need to address how we can serve them and make sure they are not forgotten.
- At what point do the [objectives get approved and prioritized](#)? I thought we did that as a group last time. Also, how will this all play out? I am on a workgroup that manages its objectives and strategies as part of [another project separate and apart from OPCC](#). Is that how all others work? I am thinking about sustainability.
- My question of proper [dissemination to cancer care stakeholders](#) as well as how to [increase utilization of the plan](#) was addressed in the meeting. I think these are key topics to address as we continue throughout the year.
- The list of objectives is very long, and the number of strategies will be even longer. The plan may become an overwhelming and will take a lot of [work to monitor and evaluate](#) over time.
- I hope we plan to make a bold [statement about racism as a public health emergency](#) in our cancer plan, while also calling out [emphasis on health equity](#). I know this can come later, but it's something I think we should include.

*N=2 people reported "No." One person was a member of the Genetics workgroup. The other was a member of three workgroups, including Cervical, Colorectal, and Pediatric cancer.

Selfishly, I am enjoying listening, learning, and sharing when I can. It's a blessing to be part of the OPCC and one day I hope to be able to offer more to the plan.
